A use fuel (diesel) vendor in Arizona is required to be licensed. No refunds will be granted without a license.

The Use Fuel Vendor Refund Request form must be used to apply for a refund of use fuel tax paid on fuel ultimately sold to light class motor vehicles or qualifying use class vehicles. Tax on use fuel sold for use in these qualifying vehicles is at the rate of \$.18 per gallon. Refer to the Vendor Refund Information Sheet for more detail regarding identification of qualifying vehicles. Since the vendor/retailer of the fuel will have paid \$.26 per gallon when purchasing use fuel for sale, there is a refund of \$.08 per gallon for fuel sold to qualifying vehicles.

All refund requests must be mailed to the address above. A copy of this form with attachments should be kept by the vendor. The vendor must complete this form in its entirety to qualify for a refund. The request will be returned for any missing information. Proper documentation must be kept to verify all claims for refund. If the amount you claim for refund is later determined to be incorrect, you may be assessed for tax due subject to penalty and interest pursuant to Arizona Revised Statutes.
