**PLEASE COMPLETE REVERSE SIDE**

1. The undersigned applicant for credit ("Customer") guarantees that all information provided on this application and agreement is true and complete. Customer agrees to be bound by all terms and conditions stated herein. The customer authorizes Mobile Force, L.L.C., all affiliated entities, and their respective agents, employees, officers, and principals (collectively "Mobile Force") to investigate Customer's credit history.
2. Any credit extended hereunder shall be for not more than 10 days and upon such terms and condition as Mobile Force may determine in its sole discretion. Credit limitations or any election not to extend Customer credit shall not be construed to be a limitation on the liability of the Customer's account or any personal guarantee. Billings unpaid within the terms established will incur a late charge of 2% per month (24% per year). A \$250.00 charge shall be levied against Customer for each returned check, which shall be immediately due and payable.
3. Mobile Force may at any time without notice refuses to permit further credit purchases, or may reduce Customer's credit limit at any time. Mobile Force may upon notice amend this agreement. Subsequent purchases shall be subject to such amendment. No cancellation or amendment will affect Customer's obligation to pay charges incurred. If Customer's account is referred for collection, Customer shall pay all attorneys' fees and costs of collection. Customer agrees that jurisdiction and venue for any contract dispute shall be at the discretion of Mobile Force.
4. Customer understands that no officer, employee, agent or assignee of Mobile Force has authority to waive any provision of this agreement, nor shall any industry custom or practice vary the expressed provisions contained herein. Any provisions under this agreement, which may prove invalid or unenforceable under any law, rule or regulation of any government agency will not affect the validity or enforceability of any other provision of this agreement. Mobile Force's failure to enforce any specific right or otherwise indulge the customer shall not be deemed a waiver of this agreement or any part of this agreement.
5. The undersigned is authorized to bind Customer to this agreement. Customer agrees to be bound by all terms and conditions stated herein.

Continuing Guaranty

1. This Guaranty applies to all sums which are due or which may become due from Customer to Mobile Force as a result of goods or services supplied until Mobile Force accepts revocation of the Guaranty in writing. Surrender or revocation thereof shall not affect the obligation of the undersigned as to any indebtedness existing at the time of such surrender or revocation.
2. Guarantors shall be liable jointly and severally and their respective community and separate properties shall be subject to the debts arising out of this Guaranty. Guarantors shall pay all reasonable cost, which Mobile Force may incur in collecting any obligation covered by this Guaranty, including court costs, and reasonable attorneys' fees whether or not a lawsuit is brought. The obligations under this Guaranty shall not be affected or waived by any time extensions or other indulgences granted customer by Mobile Force.
3. This is a guaranty of payment, not a guaranty of collection. The Guarantor waives (a) any right to require Mobile Force to proceed against Customer, (b) any other remedy in Mobile Force power whatsoever, (c) all rights Guarantor may have under A.R.S. Sections 12-1641 and 12-1642, (d) any defense arising by reason of any disability or other defense of the Customer or by reason of the cessation, from any cause whatsoever, of the liability of Customer, and (e) all presentments, demands for performance, notices of protest or notices of dishonor.
4. This Guaranty shall be interpreted according to the laws of Arizona, where it is intended to be performed. Guarantor agrees that jurisdiction and venue for any lawsuits shall be at the discretion of Mobile Force.
5. If there is no spousal signature below, each Guarantor represents that he/she is unmarried and specifically intends that Mobile force rely on such representation.
